

WA Concerns Form

STRICTLY CONFIDENTIAL – DO NOT SHARE

Thank you for raising your concern. We understand this may be a difficult step; we will endeavour to help and support you and try and make the process as stress-free as possible.

Please complete the form below, sharing as much information as you feel comfortable providing. If you would prefer, we can meet with you to complete it together.

This form helps us respond with care—supporting the person affected, meeting legal obligations such as mandatory reporting and potential police involvement, and providing enough detail to guide early steps in assessing risk and deciding whether further investigation is needed. Reports may be submitted by third parties or anonymously; however, a report with sufficient detail is necessary where action is expected or requested.

This form is for reporting allegations or complaints related to **Child Sexual Abuse (“CSA”)** within the church. For details on what constitutes CSA please refer to WA Government link [Identifying child abuse and neglect](#)

REPORTING

To ensure concerns are addressed promptly and appropriately, we recommend the following pathways:

- **Church-related Sexual Abuse**
 - Report directly to WA Police or Child Protection or authorities in relevant location/jurisdiction.
 - Report to the WA Overseer, or Worker (in addition to reporting to authorities).
- **Non-church related Sexual Abuse**
 - Report directly to WA Police or Child Protection or authorities in relevant location/jurisdiction.
 - If the adult survivor wishes to also inform the church, then they are invited to do so through a ministry worker who will listen and provide appropriate support as able to do so.

If anyone forms a reasonable belief that a child is being harmed or at risk of harm in a particular meeting or situation you are encouraged to contact WA Child Protection Central Intakes Team on 1800 273 889.

THE PROCESS

Thank you for completing this form. We appreciate your help and will reach out to you shortly. Once we have all the details required, we’ll review the concern to determine whether it falls within the scope of matters we’re able to address.

The handling of a concern can take time, and we appreciate your patience.

Please note that, on occasion, police may request that the person subject of allegation (PSOA) not be notified immediately, to avoid interfering with their investigation. Once police provide clearance, we may proceed with the next steps.

Any allegation must be substantiated before any permanent changes to the PSOA’s meeting arrangements, attendance or duties are considered.

PRIVACY & CONFIDENTIALITY

All information will be treated in strict confidence and shared only with those directly handling the matter, relevant parties, and authorities (if required). This safeguards the integrity of the inquiry and supports procedural fairness.

Until the allegation has been substantiated, it’s important that all individuals’ privacy is respected to reduce the risk of re-traumatisation or defamation. The person subject of the allegation may be notified of the claim against them and invited to respond.

This report may be shared with external bodies such as police, child protection services, independent investigators, or professional risk assessors. Interviews with those involved may be required as part of the process.

Definitions

Church-Related Child Sexual Abuse (CSA)- Refers to alleged sexual abuse perpetrated by a ministry worker, or elder in the course of their duties, or abuse that occurred at or in connection with a ministry-organised meeting or meeting environment.

Current Child Abuse- Refers to instances of alleged abuse where the victim is under the age of 18 in the present.

Historical Child Abuse- Refers to alleged abuse that occurred during childhood, where the victim is now an adult (18 years or older at the time of disclosure).
